Special Meeting  
August 23, 2013**

AT A REGULAR MEETING OF THE LEWIS COUNTY FISCAL COURT, HELD AT THE COURTHOUSE IN VANCEBURG, KENTUCKY WITH THE HONORABLE STEVE APPEGATE PRESIDING AND WITH THE FOLLOWING MAGISTRATES IN ATTENDANCE: ESQ. MILT STANFIELD, ESQ. PAUL B. SWEARINGEN (ABSENT) AND ESQ. JOE BENTLEY.

The meeting was called to order by Johnny Bivens, Lewis County Sheriff.

A prayer was offered by Milt Stanfield.

The Pledge of Allegiance was lead by Judge Steve Applegate

The roll was called and all were present.

**NEW BUSINESS**

**SET TAX RATES FOR REAL ESTATE AND TANGIBLE PROPERTIES FOR THE YEAR 2013**

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to order the following tax rates be levied for the **COUNTY OF LEWIS** for the year 2013.

- (1) Upon each \$100.00 of **Real Estate** and including Property for Public Service Companies for general purposes, a tax levy of **13.0**.
- (2) Upon each \$100.00 of **Tangible Personal and Public Service Companies**, a tax levy of **14.0**.
- (3) Upon each \$100.00 of **Motor Vehicle and Watercraft**, a tax levy of 14.1.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to set the following tax rate on **TIMBERLAND AND FORESTED ACRES** for the year of **2013**, to be set at a levy of **.03** per acre.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to acknowledge the following tax rates were set by the **LEWIS COUNTY LIBRARY BOARD OF TRUSTEES** for the **LEWIS COUNTY PUBLIC LIBRARY TAX DISTRICT** for the year **2013**.

- (1) Upon each \$100.00 of Real Estate and including Property for Public Service Companies for general purposes, a tax levy of 6.1.
- (2) Upon each \$100.00 of Tangible Personal and Public Service Companies, a tax levy of 10.25.
- (3) Upon each \$100.00 of Motor Vehicle and Watercraft, a tax levy of 1.76.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to acknowledge the following tax rates were set by the **LEWIS COUNTY BOARD OF EDUCATION** for the **LEWIS COUNTY SCHOOL DISTRICT** for the year 2013.

- (1) Upon each \$100.00 of Real Estate and including Property for Public Service Companies for general purposes, a tax levy of 41.3.
- (2) Upon each \$100.00 of Tangible Personal and Public Service Companies, a tax levy Of 41.3
- (3) Upon each \$100.00 of Motor Vehicle and Watercraft, a tax levy of 49.0

On a motion made by Joe Bentley duly seconded by Paul Swearingen with all members voting yes to acknowledge the following tax rates were set by the **LEWIS COUNTY HEALTH DEPARTMENT**, for the **LEWIS COUNTY HEALTH TAXING DISTRICT** for the year **2013**.

- (1) Upon each \$100.00 of Real Estate and including Property for Public Service Companies for general purposes, a tax levy of **3.50**.
- (2) Upon each \$100.00 of Tangible Personal and Public Service Companies, a tax levy of **3.90**.
- (3) Upon each \$100.00 of Motor Vehicle and Watercraft, a tax levy of **3.90**.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to acknowledge the following tax rates for **FIREBRICK, BLACK OAK, KINNICONICK, CAMP DIX, TOLLESBORO, GARRISON AND LEWIS COUNTY VOLUNTEER FIRE DEPARTMENT DISTRICTS**, for the year of **2013**, be and the same are here levied and imposed:

- (1) Upon each \$100.00 of **Real Estate and including Property for Public Service Companies** for general purposes, a tax levy of **.10**.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all members voting yes to acknowledge the following tax rates for the **LEWIS COUNTY EXTENTION DISTRICT**, for the year **2013**.

- (1) Upon each \$100.00 of Real Estate and including Property for Public Service Companies for general purposes, a tax levy of **5.6**
- (2) Upon each \$100.00 of Tangible Personal and Public Service Companies, a tax levy of **9.0**
- (3) Upon each \$100.00 of Motor Vchicle and Watercraft, a tax levy of **3.12**.

On a motion made by Milt Stanfield duly seconded by Joe Bentley with all members voting yes to advertise for bid the **2014 Fiscal Year Flex Funds**.

On a motion made by Joe Bentley duly seconded by Milt Stanfield with all other members voting yes to approve the contract and issue payment for the **radio tower sight** with **Anthony Silvey** in the amount of \$3500.00.

On a motion made by Milt Stanfield duly seconded by Joe Bentley with all members voting yes to advertise for bid for a **new grader** for the **Lewis County Road Department**.

On a motion made by Milt Stanfield duly seconded by Joe Bentley with all members voting yes to approve claims. See **Finance Book #4**
